- 1. <u>Purpose</u>. Assist 2d Marine Logistics Group (MLG) subordinate units in preparing and executing local boards to screen nominees for meritorious promotion to the ranks of Corporal and Sergeant, as well as Marine and Noncommissioned Officer (NCO) of the Quarter, by providing a consolidated list of due dates as depicted in the enclosure.
- 2. <u>Background</u>. References (a) and (b) outline the administrative procedures and submission deadlines to nominate Marines for meritorious promotion and Marine/NCO of the Quarter. The available processing time between unit submissions and the effective date of promotions and awards is already restrictive. Delays caused by untimely submissions decreases the likelihood that promotion warrants and award certificates may be made available for presentation at the optimal opportunity.

3. Action

a. <u>Sergeants Major</u>. Disseminate information from the references and the enclosure for maximum visibility, and apply strict screening procedures to ensure only the best and fully qualified personnel are submitted in a timely manner.

b. Unit S-1

- (1) Utilize the references and the enclosure to anticipate deadlines and initiate preparation of packages far enough in advance to allow for a thorough review and timely submission via the chain of command.
- (2) Prior to submission to 2d MLG, validate eligibility requirements, administrative correctness of the package(s), and the presence of required material to ensure a complete submission. Nomination packages are expected to be screened and submitted by the unit S-1 to the G-1 Adjutant office.

c. 2d MLG G-1 Chief

(1) Include deadlines depicted in the enclosure on the weekly Adjutant Calendar on Sharepoint and/or email to increase visibility.

- (2) Receive and screen nomination packages from subordinate elements for submission to the Sergeant Major prior to the execution of the 2d MLG boards.
- 4. Reserve Applicability. This Bulletin is applicable to the 2d MLG Total Force.
- 5. <u>Cancelation Contingency</u>. This Bulletin will be canceled upon annual review.
